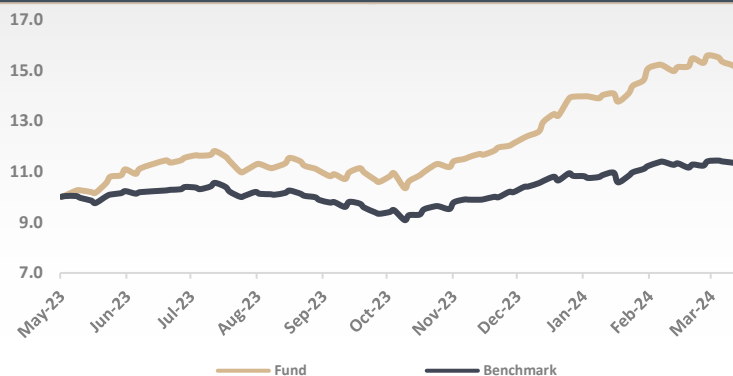

## Performance Since Inception



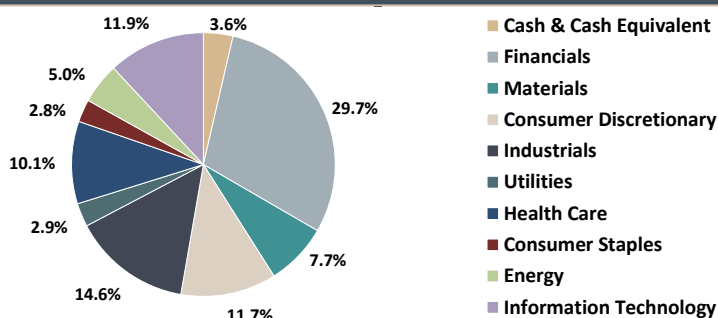

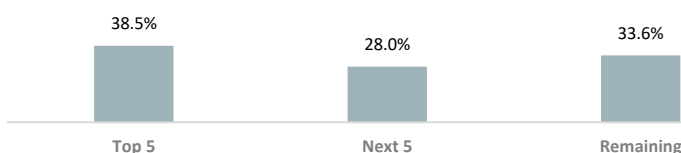
